PROPOSITION 1

Shall the Clarksburg C-2 School District of Moniteau County, Missouri issue its general obligation bonds in the amount of \$1,000,000 for the purpose of constructing, improving, furnishing and equipping school sites and facilities, including the construction of new elementary classrooms?

If this proposition is approved, the debt service levy of the school district is estimated to remain unchanged at \$0.7258 per \$100 of assessed valuation.

Proposition KIDS

Shall the Board of Education of the Prairie Home R-V School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Dollars (\$1,000,000) for the purpose of providing funds to construct, equip, and furnish new restrooms at the High School and Junior High that will also function as a storm shelter; to remodel the Elementary School classrooms providing increased safety to students; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.4664 per one hundred dollars of assessed valuation of real and personal property.

Proposition K.I.D.S (Keep Improving District Schools)

Shall the Board of Education of the Pilot Grove C-4 School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000) for the purpose of providing funds to implement safety and security improvements, including secure entrances, exterior and interior door upgrades, replacement of the bell system and fire alarms, and new cameras; to replace heating, ventilation, and air conditioning (HVAC) systems for increased energy efficiency; to complete improvements to the District's outdoor athletic facilities; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.7173 per one hundred dollars of assessed valuation of real and personal property.
