## "I Voted" Sticker Design Contest Rules

By Submitting an entry, you agree to be bound by the following "Official Rules" of the contest

### 1. SPONSOR

- This contest is sponsored by the Cooper County Clerk's Office & Sarah Herman.

### 2. ELIGIBILITY

- Resident of Cooper County, Missouri
- Currently enrolled in 6<sup>th</sup> through 12<sup>th</sup> grade (or equivalent to home schooled students)
- Immediate family members of the Sponsor or members of their household are not eligible to participate.

### 3. HOW TO ENTER

- The contest will begin on November 10, 2021. To enter, you must submit your artwork, Design Entry Form electronically at [clerkdeputy@coopercountymo.gov](mailto:clerkdeputy@coopercountymo.gov) or to the Cooper County Clerk's office 200 Main Street, Room 23, Boonville, Mo 65233. Minors under the age of 18 must complete a Parental Consent Form. All art work must be received by 11:59 p.m. on December 1, 2021. Late entries will not be accepted. Multiple entries are permitted. ### 4. DESIGN REQUIREMENTS

- The design must include the phrase "I Voted" and correspond with the theme of Voting and elections. The dimensions of the design should fit on a square sticker 2x2. To accommodate print quality, designs could be submitted as vector files, or high-resolution JPG, PNG, TIF, or PDF file types with a **minimum resolution of 300 dpi**. Max 10 MB file size or in person. The sponsor may require the original artwork of the winners to be submitted for print quality purposes, therefore, Contestants should maintain their original work.

### 5. PUBLIC VOTING

Designs will be evaluated by the Public

- Visual aesthetics
- Originality
- Pro-voting message

Winners will be announced by January 2<sup>nd</sup> at 5 p.m.

### 6. VOTING RULES

- Winners are encouraged to tell family and friends about the competition and ask them to participate in voting. Activity that deems to be fraudulent, unfair, or unethical is not permitted and may result in the removal of a design entry or disqualification of a contestant.

### 7. VERIFICATION OF WINNER

- All potential winners are subject to verification by the Sponsor. A potential winner and first and second runners-up will be notified by January 2, 2022, using the contact information provided on the Design Entry Form. If the winner and runners-up cannot be verified, the Sponsor will fill the positions with the finalist(s) with the next highest votes from the public voting.

### 8. CONTEST WINNER AND RUNNERS-UP

- The winner's artwork design will be used as the official "I Voted" Sticker of Cooper County, Missouri for the 2022-2023 election years and will be offered to all voters who cast ballots in elections during those years.
- The name and artwork of may appear on media outlets such as television, radio, and newspaper and their respective social media platforms.
- First place winner in addition to the use of their I Voted sticker design will receive a \$50 gift card,

second place will receive \$25 gift card and third will receive \$10 gift card donated by Sarah Herman.

## 9. OWNERSHIP OF ENTIREES

- The Sponsor does not claim ownership to the contest entries. By completing the Design Entry Form and submitting artwork, you are acknowledging that you have read and agree to these Official Rules and to release of liability. In addition, you agree to grant the Sponsor a non-exclusive, fully paid-up and royalty-free, worldwide license to use, modify, delete from, add to, publicly perform, publicly display, reproduce and translate your design entry, including without limitation the right to distribute all or part of your design entry in any media or social media formats and channels in perpetuity. By submitting a design entry, you agree and consent to the use of your design, name, school name, and photograph by the Sponsor, its affiliates, subsidiaries, parents, and licensees in connection with the contest and related marketing activities, in any media format or channels now known or hereafter invented, in any and all locations, without any payment to or further approval from you. You agree that this consent is perpetual and cannot be revoked.

## 10. REPRESENTATIONS AND WARRANTIES

By submitting an entry, you agree that your entry:

- is your original artwork;
- does not contain words or images that are obscene, inappropriate, or defamatory, according to the judgement of the Sponsor;
- does not infringe or violate the copyrights, trademarks, rights of privacy, publicity or other rights of any person or entity;
- does not contain malicious code, such as viruses, timebombs, cancelbots, worms, Trojanhorses, or other harmful programs or information;
- does not and will not violate any law, statute, ordinance, rule, or regulation;
- does not feature the likeness of private individuals without the individuals' explicit written permission for its use;
- does not trigger any reporting or royalty obligation to any third party; and
- **does not contain any words, symbols, or images that are partisan in nature to any political party, ideological thought, or controversial issue**

You also agree that the rights that you are granting under these Official Rules do not conflict with any other agreement to which you are a party or have entered into, or with any commitments, restrictions, or obligations that you are under to any other person or entity. **OTHER TERMS AND CONDITIONS**

## 11. OTHER TERMS AND CONDITIONS

**Entry Conditions and Release:** By entering the contest, each contestant agrees to:

- a) Comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this contest;
- b) release and hold harmless the Sponsor, and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the contest, and all of their respective past and present officers, directors, employees, agents and representatives ("Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a contestant's entry, creation of an entry or submission of an entry, participation in the contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, transmission, performance, exploitation or use of entry; and
- c) indemnify, defend and hold harmless the Sponsor from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to a contestant's participation in the contest and/or contestant's acceptance, use or misuse of prize.

**Publicity:** Except where prohibited, participation in the contest constitutes the winner's consent to the Sponsor's and its agents' use of the winner's names for promotional purposes in any media, worldwide, without payment or consideration.

**General Conditions:** The Sponsor reserves the right to cancel, suspend and/or modify the contest, or any part of it, including the dates of the contest, if any fraud, technical failures, or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the contest, as determined by the Sponsor in its sole discretion, or for any other reason whatsoever. The Sponsor reserves the right in its sole discretion to disqualify any individual or competitor it finds to be tampering with the entry process or the operation of the contest or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the contest may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. The Sponsor is not responsible for, nor are they required to count incomplete, late, misdirected, damaged, unlawful, or illicit votes, including those secured through payment, votes achieved through automated means or by registering more than one e-mail account and name, using another contestant's e-mail account and name, as well as those lost for technical reasons or otherwise.

**Limitations of Liability:** The Released Parties are not responsible for:

- a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the contest;
- b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software;
- c) unauthorized human intervention in any part of the entry process or the contest;
- d) technical or human error which may occur in the administration of the contest or receipt or use of any prize.

If for any reason an entrant's submission is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is to provide another submission.

**Disputes:** Entrant agrees that:

- a) any and all disputes, claims and causes of action arising out of or connected with this contest, or any prizes awarded, other than those concerning the administration of the contest or the determination of the winner, shall be resolved individually, without resort to any form of class action;

By signing this Parental Consent Form:

1. I hereby agree that my minor child may participate in the "I Voted" Sticker Design Contest being hosted by the Cooper County Clerk's Office ("Sponsor"), and irrevocably grant my permission and authorize the Sponsor to use my minor child's name, school, artwork, and photograph for purposes of the contest. I also agree that my child's name, school, artwork, and photograph will be used in advertising, marketing, and promoting the contest, and to reproduce and publish the same throughout the universe in perpetuity, in any and all media now known or hereinafter devised. I further agree that the contest, my minor child's participation in the contest and all of the contest elements belong entirely and exclusively to the Sponsor, so that the Sponsor and its licensees and assigns may duplicate, distribute, broadcast, exhibit, or otherwise use the contest without limitation or restriction throughout the universe in perpetuity. I agree that neither I nor my minor child shall make any claims against the Sponsor based upon distribution of the material or the contest and its elements to which I have consented on behalf of my minor child. I release the Sponsor and its licensees and assigns from any and all claims and liabilities whatsoever that may occur in relation to or arising from my minor child's participation in the contest. I agree that this consent and release will be governed by and construed in accordance with the laws of the State of Missouri.
4. I confirm that my minor child lives in the United States of America, State of Missouri, and County of Cooper.
5. I agree that my minor child may participate in the contest described in the Official Rules.

I understand my minor child's name and other information that I provide on behalf of or related to my minor child, as described in the Official Rules, may be posted together with my minor child's submission upon the Sponsor's website and social media platforms, as well as other public forums, such as the media, without any additional notice to or permission by me.
7. I hereby warrant that I am a legally competent adult and a parent or legally appointed guardian of the minor child named below, and that I have every right to contract for the minor child in the above regard.

I certify and acknowledge that I have read, understood and agree to the Official Rules of the contest, and that I have read this Parental Consent Form prior to signing it; that I have the full authority to give my consent and release so that my minor child may participate in the contest and that I consent to provide the information concerning my minor child that is necessary to enter the contest and if selected, to be awarded a finalist, runner-up, or winner.

Accordingly, and intending to be legally bound, I voluntarily agree to the terms set forth herein and acknowledge and agree that my minor child and myself are bound by the Official Rules and I am bound by the terms of this Parental Consent Form. This release shall be binding upon my minor child, me, and our respective heirs, legal representatives, and assigns.
